LSAT

The Law School Admission Test (LSAT) is a half-day standardized test required for admission to all ABA-approved law schools. It provides a standard measure of acquired reading and verbal reasoning skills that law schools can use as one of several factors in assessing applicants.

Getting Your Score: if you have an LSAC online account, you will receive your LSAT score by **e-mail** approximately 3 weeks after taking the test. This is the fastest way to receive your score, and there is no charge. Make sure to keep your email address current with your LSAC online account to receive your score promptly.

Preparing for the LSAT

- It is recommend that you spend approximately 200 hours preparing for the LSAT, but this varies by student.
- Options to help you prepare include:
 - Actual, Official LSAT PrepTests™ (www.lsac.org)
 - LSAT preparation books and online resources
 - Commercial preparation courses

Taking the LSAT multiple times:

While many law schools will consider your highest score if taken multiple times, all schools will receive all of your scores and some may average multiple scores. Plan and prepare to take the LSAT only once.

CAS

The Credential Assembly Service (CAS) provides a means of centralizing and standardizing undergraduate academic records to simplify the law school admission process. Nearly all ABA-approved law schools require that their applicants register for CAS. The CAS prepares and provides a report for each law school to which you apply. Your report will include: 1) an undergraduate academic summary; 2) copies of all undergraduate, graduate, and law/professional school transcripts; 3) LSAT scores and writing sample copies; and 4) copies of letters of recommendation processed by LSAC. Your CAS period will extend for five years from your registration date. The subscription includes one report.
